Dr. Campbell is Associate Professor of Laboratory Medicine, and Associate Chief for Laboratory Medicine at VA Connecticut, specializing in diagnostic microbiology. He directed the Medical Microbiology and Infectious Disease course for the past lots of years, and is now co-director of the Attacks and Defenses course in the Integrated Curriculum. A Bohmfalk award winning teacher, he is infamous as the Singing Microbiologist. Dr. Campbell has presented his approach to passionate teaching to national and international audiences.
